- 8. Application and attachments should be submitted to the church office each year before the first Sunday in June.
- 9. Applicant must write their "Personal Vision" in 100 words or less.

❖ LEVEL OF PERSONAL CHURCH ACTIVITIES

❖ QUALITY AND CONTENCT OF 'Personal Vision'

Letters of recommendation from the student's high school guidance counselor or teacher; college/trade school advisor, professor or teacher.

Letter/s of recommendation from current and/or past employer. Focus of letter should be on student's character, motivation and work and study ethics.

❖ PARTICIPATION IN SCHOOL OR COMMUNITY ACTIVITIES/PROJECTS

List of all community activities or organizations (e.g. scouts, nursing home/hospital volunteering, etc.).

List of al school activities or organizations (e.g. band, choir, sports).
